- (3) Major decisions taken by the members in pursuance to Section 180 of the Companies Act, 2013.



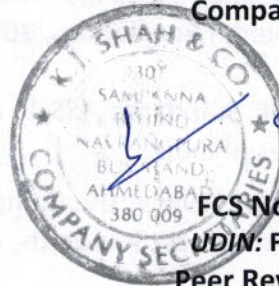

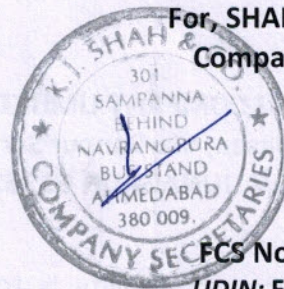
- a. Maintenance of Secretarial record is the responsibility of the management of the Company. Our responsibility is to express an opinion on these secretarial records based on our audit.
